GENERAL INFORMATION

1-1 Intent

It is the intent of this Invitation to Bid to establish contract(s) for the supply and delivery of various musical instruments, equipment, accessories and service for Lowndes County Schools Band programs.

1-2 Scope

Successful bidder(s) will be responsible for the furnishing, delivery and installation, where applicable, of the specified instruments, equipment and accessories to Lowndes County Schools within the contract period. Successful bidder(s) must also maintain and provide service to the instruments as long as Lowndes County Schools keeps said instruments on inventory.

1-3 Delivery

Delivery of all items must be delivered inside the hours of 8:30am and 3:30pm excluding school holidays.

1-4 Compliance with Specifications

The successful bidder shall abide by and comply with the true intent of the specifications and not take advantage of any unintentional error or omission, but shall fully complete every part of the true intent and meaning in the specifications.

1.5 Unit Prices

All unit prices must remain firm during the contract period and shall not change until a Purchase Order is issued from Lowndes County Schools on July 1, 2018.

1.6 **Product**

The instruments listed are specific to the brand and no substitutions will be allowed.

1-8 Warranty

All equipment will adhere to the manufactures warranty.

2-1 **Bid Submittal**
